

**FLASH FOODS AND HERSHEY/REESES MOVIE TICKET GIVEAWAY
OFFICIAL RULES**

The following Sweepstake is intended for residents of Florida and Georgia only and shall only be construed and evaluated according to the laws of the United States. Do not enter this Sweepstakes if you are not a resident of Florida or Georgia at the time of entry.

1. **TWO WAYS TO ENTER:**

A) Beginning 12:00 AM Eastern Daylight Time (“EDT”) on 3/29/10 through 11:59 PM (EDT) on 5/30/10, each time you purchase a **HERSHEY/REESES King Size product** using your Flash Foods “Rewards In A Flash” Loyalty Card or GOBlue Payment Card at participating Flash Foods stores in the states of Georgia and Florida you are automatically entered into the Grand Prize Drawing for the day of your purchase.
